In 2017, Freedom Service Dogs acquired Disco's Dogs, a Colorado nonprofit founded in 2013 that provides specially trained service dogs and skilled companion dogs for individuals with autism related differences. Although Freedom Service Dogs already services clients with autism, the acquisition has allowed Freedom Service Dogs to expand clients served from children 12+ years old to children 5+ years old and introduced a new training model which allows families to be an integral part of the training process. Disco's Dogs assets of \$17,056.08 were transferred to Freedom Service Dogs upon finalization of the acquisition in August 2017.

Form 990, Part III, Line 4a - Program Service Accomplishments

The client-dog teams are Freedom Service Dogs' core program and encompasses 3 types of client-dog teams: Professional Service Dog teams, Skilled Companion teams and Professional Therapy Dog teams. A Professional Service Dog team pairs a full public access dog with a person living with disabilities such as a spinal cord injury, Multiple Sclerosis, Cerebral Palsy, Post Traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI) or Autism. A Skilled Companion matches a dog that does not have public access with a person with the same disabilities as mentioned above. The Skilled Companion dog can do the same tasks as a Professional Service Dog, but does them at home for the client and does not go out in the public with that person. A Professional Therapy Dog team pairs a licensed therapist with a dog that they will use in their therapy/counseling practice or facility.

Client-Dog teams are considered the main metric of the mission. FSD graduated and paired 29 teams in 2017 including 11 traditional clients, 13 veteran clients and 5 professional therapist clients.
