Public education and outreach: Annually FSD provides a variety of educational programs including working with at-risk youth in schools and community programs; working with developmentally disabled children and adults in a variety of settings; and educating corporate and community-based groups on FSD mission and impact. In 2016, volunteers committed more than 6,600 hours of service helping with educational programs, events and administrative tasks. More than 285 at-risk youth were reached thru Pawsitive Connection Program and more than 750 youth and adults were reached through FSD trained therapy dogs.

Freedom Service Dogs custom trains rescue dogs to become therapy dogs and service dogs. The service dogs transform the lives of people with visible and invisible disabilities. Clients include children, veterans and active duty military, and other adults.

Form 990, Part III, Line 4a - Program Service Accomplishments

The client-dog teams are Freedom Service Dogs' core program and encompasses 3 types of client-dog teams: Professional Service Dog teams, Skilled Companion teams and Professional Therapy Dog teams. A Professional Service Dog team pairs a full public access dog with a person living with disabilities such as a spinal cord injury, Multiple Sclerosis, Cerebral Palsy, Post Traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI) or Autism. A Skilled Companion matches a dog that does not have public access with a person with the same disabilities as mentioned above. The Skilled Companion dog can do the same tasks as a Professional Service Dog, but does them at home for the client and does not go out in the public with that person. A Professional Therapy Dog team pairs a licensed therapist with a dog that they will use in their therapy/counseling practice or facility.

Client-Dog teams are considered the main metric of the mission. FSD graduated and paired 22 teams in 2016 including 11 traditional clients, 6 veteran clients and 5 professional therapist clients.

FSD is a certified Assistance Dog International organization. FSD took in 114 rescue dogs in 2016. The dogs which do not graduate into service, therapy or skilled companion dogs are adopted out to a forever home. FSD has hundreds of volunteers who assist with walking dogs, socializing dogs and training dogs.
